The purpose for this notice is to inform you of our all activities meeting, as well as some important dates and reminders that you need to be aware of for the upcoming school year. This is a lengthy email so please carefully read it in its entirety.

·The All Activities Meeting will be held on **Tuesday, August 7<sup>th</sup>, 2018 at 7:00 pm** in the **Butte Central High School Auditorium**. Please show up early so we can start right at 7 pm. All students planning on participating in ANY activity during the 2018-19 school year **MUST** attend this meeting with at least one parent/guardian. Following the meeting, there will be breakout meetings for all fall activities.

·The first allowable date for golf practice is Thursday, August 9<sup>th</sup>. The first allowable date for all other fall activities(football, volleyball, cross country & cheerleading) is Friday, August 10<sup>th</sup>. Dates & times for practices will be established and announced by each activity's respective head coach.

·Homecoming week for 2018 is scheduled for September 24-29.

·Please be reminded that the Montana High School Association mandates that authorized physical forms be on file in the Activities Office **prior** to participation in any activity(except Speech & Choir). Be sure to use the most recent MHSA physical form(*updated 03/10*). Butte Central High School also requires a "Treatment Authorization form" to be on file. **Students will not be allowed to participate in practice until these forms are completed and on file. ·The State of Montana now has the Dylan Steigers Protection of Youth Athletes Act. The law requires that ALL athletes and their parents receive information and sign a form prior to any athlete competing.
